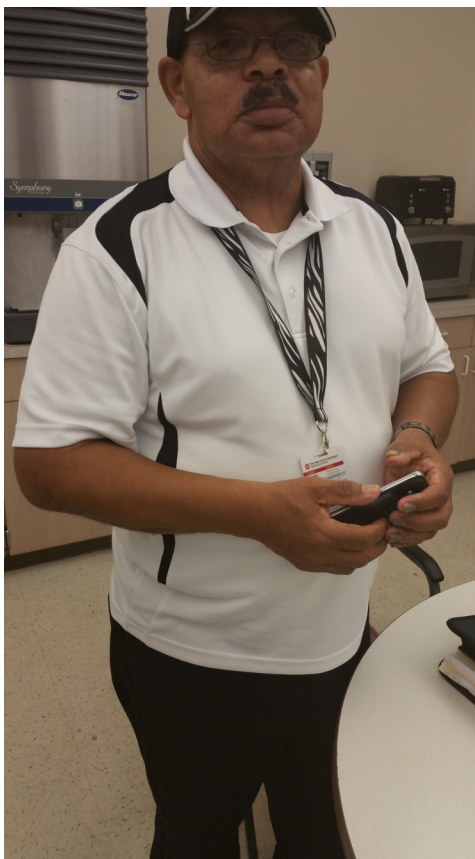
Farewell, Mr. Newman. *Best of Luck* to you with whatever you choose to do next in life.

# The shadow of things that will be, or that may be? by Michael Secrest

A Pennsylvania based company, American Future Systems, Incorporated, was charged 1.75 million dollars for **forcing their employees to clock out for restroom breaks.**

We have also heard about Wal-Mart's long track record of worker abuse, from forced overtime to sex discrimination to illegal child labor to relentless union busting. **Wal-Mart also notoriously fails to provide health insurance to over half of its employees, who are then left to rely on themselves or taxpayers,** who provide for a portion of their healthcare needs through government Medicaid.

Menards, the big box home supply store, forced their managers to

sign a contract saying the manager's **salary would be reduced by 60% if a union formed** in a store they supervised.

So far, it is not so bad for us. But you should know that my retirement pay just this year got reduced by 20%. I called for an explanation and was told it was because this is the year they start reducing pay for coverage for spouses. By 2018 OPERS will not insure spouses at all. Work all your life for something and be forced to sit and watch it disappear like smoke rings in the dark.

These abusers have two things driving them. Greed and fear. One hand is around the throats of workers, squeezing out every possible

penny and the other very heavy hand is a clenched fist being shaken at unionism, and ready to grasp any weapon to fight the resurgence of the American workers' demands for what they deserve.

The future we sit and watch others write will be very different from the future we can write for ourselves. If we will only pick up the pen.

## Hillary Clinton Dominates Union Endorsements, But The CWA Is Endorsing Bernie Sanders

Hillary Clinton has dominated when it comes to labor union endorsements in the 2016 presidential primary. She has racked up backing from AFSCME, SEIU, the American Federation of Teachers, the National Education Association, North America's Building Trades, and the Machinists union among others. But on Thursday the Communications Workers of America decided to back Senator Bernie Sanders. The CWA's Candice Johnson says

CWA members prefer Sanders because he's a candidate they think will break away from politics as usual and fight for working people. [Candice Johnson]: "Our members are proud to stand with a candidate like Bernie Sanders, who takes on corporate greed, who's fighting back standing up against the big banks. Who is taking on the flood of money in politics that's just really destroying the political system and the value of working people's votes. When a few billionaires can control our political process some-

thing's wrong. The whole idea of a new day, a new agenda for our politics and for our economy has really caught on and caught fire. Not just among CWA members, not just among union members, but among working families across the country."

Sanders is also backed by the American Postal Workers Union and National Nurses United.

Management and their Human Resources Departments are so reluctant to affirm a grievance that they say things like this response to this September 15 hearing “after the grievance was filed, in June 2015, department supervisors ceased in assigning overtime in the manner which led to the original filing.... This grievance is denied.”

And this response: “.....the Union’s assertion that an erosion of the bargaining unit exists appears to be premature.” Not unwarranted, but premature! And they are not saying that the erosion is not happening, but are saying that our awareness and protesting of it are premature. A very telling phrase. They don’t want us to protest until it is established practice and too late.

And this is the most telling: .....”there has been no adverse impact on any bargaining unit member currently classified as a Patient Transporter at the present time. ....the grievance is denied” They are pretending that they are not trying to destroy your union by eliminating Bargaining Unit positions and by trying everything they feel might be a loophole.

Stand up, fight back or be rolled over.
